Bearings, headings, courses, tracks and radials are magnetic. Elevation and altitudes are in feet MSL. Altitudes are minimum altitudes unless otherwise indicated.
Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

TAKEOFF MINIMUMS:

RWY 7, 14, 25 STANDARD.

RWY 32, 300-1 1/4 OR STANDARD WITH MINIMUM CLIMB OF 375 FT PER NM TO 500.

TEXTUAL DEPARTURE PROCEDURES:

RWY 25 – CLIMB HEADING 255.37 TO 1100 BEFORE TURNING RIGHT.

RWY 32 – CLIMB HEADING 330.91 TO 1600 BEFORE TURNING LEFT.

NOTE: RWY 7, VEHICLES ON ROAD, ANTENNA, LIGHT SUPPORT STRUCTURE, TRANSMISSION TOWER, AND TREES BEGINNING 62 FT FROM DER, 4 FT LEFT OF CENTERLINE, UP TO 69 FT AGL/309 FT MSL. TREES BEGINNING 220 FT FROM DER, 19 FT RIGHT OF CENTERLINE, UP TO 72 FT AGL/311 FT MSL.

NOTE: RWY 14, TREES BEGINNING 149 FT FROM DER, 320 FT LEFT OF CENTERLINE, UP TO 55 FT AGL/294 FT MSL. BUSHES AND TREES BEGINNING 93 FT FROM DER, 260 FT RIGHT OF CENTERLINE, UP TO 81 FT AGL/320 FT MSL.

NOTE: RWY 25, TREES BEGINNING 118 FT FROM DER, 511 FT LEFT OF CENTERLINE, UP TO 60 FT AGL/379 FT MSL. TREES BEGINNING 245 FT FROM DER, 476 FT RIGHT OF CENTERLINE, UP TO 82 FT AGL/321 FT MSL.
