RWY 7: CLIMBING LEFT TURN DIRECT SAC VORTAC. CONTINUE CLIMB IN SAC VORTAC HOLDING PATTERN (HOLD, S, RT, 016.01 INBOUND) TO CROSS SAC VORTAC AT OR ABOVE MEA FOR ROUTE OF FLIGHT.

RWY 15: CLIMB TO 800 THEN CLIMBING LEFT TURN DIRECT SAC VORTAC. CONTINUE CLIMB IN SAC VORTAC HOLDING PATTERN (HOLD, S, RT, 016.01 INBOUND) TO CROSS SAC VORTAC AT OR ABOVE MEA FOR ROUTE OF FLIGHT.

RWY 25: CLIMBING RIGHT TURN DIRECT SAC VORTAC. CONTINUE CLIMB IN SAC VORTAC HOLDING PATTERN (HOLD, S, RT, 016.01 INBOUND) TO CROSS SAC VORTAC AT OR ABOVE MEA FOR ROUTE OF FLIGHT.

RWY 33: CLIMBING RIGHT TURN DIRECT SAC VORTAC. CONTINUE CLIMB IN SAC VORTAC HOLDING PATTERN (HOLD, S, RT, 016.01 INBOUND) TO CROSS SAC VORTAC AT OR ABOVE MEA FOR ROUTE OF FLIGHT.
