TAKEOFF MINIMUMS:

RWY 10: STANDARD WITH MINIMUM CLIMB OF 365 FT PER NM TO 10000 OR 3600-3 FOR VCOA.
RWY 16: STANDARD WITH MINIMUM CLIMB OF 305 FT PER NM TO 10500 OR 3600-3 FOR VCOA.
RWY 28: STANDARD WITH MINIMUM CLIMB OF 500 FT PER NM TO 11000 OR 3600-3 FOR VCOA.
RWY 34: STANDARD WITH MINIMUM CLIMB OF 390 FT PER NM TO 11300 OR 3600-3 FOR VCOA.

RWY 10: CLIMB HEADING 104.10 TO 9000 BEFORE PROCEEDING ON COURSE.
RWY 16: CLIMB HEADING 164.10 TO 8900 BEFORE PROCEEDING ON COURSE.
RWY 28: CLIMB HEADING 284.11 TO 8000 BEFORE PROCEEDING ON COURSE.
RWY 34: CLIMB HEADING 344.10 TO 9800 BEFORE PROCEEDING ON COURSE.

VISUAL CLIMB OVER AIRPORT:

ALL RUNWAYS: OBTAIN ATC APPROVAL FOR VCOA WHEN REQUESTING IFR CLEARANCE. CLIMB IN VISUAL CONDITIONS TO CROSS BEAR LAKE COUNTY AIRPORT AT OR ABOVE 9400 BEFORE PROCEEDING ON COURSE.
