Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

RWY 16: 300-1 7/8 OR STANDARD WITH MINIMUM CLIMB OF 211 FT PER NM TO 700, OR ALTERNATIVELY, WITH STANDARD TAKEOFF MINIMUMS AND A NORMAL 200 FT PER NM CLIMB GRADIENT, TAKEOFF MUST OCCUR NO LATER THAN 1500 FEET PRIOR TO DER.
