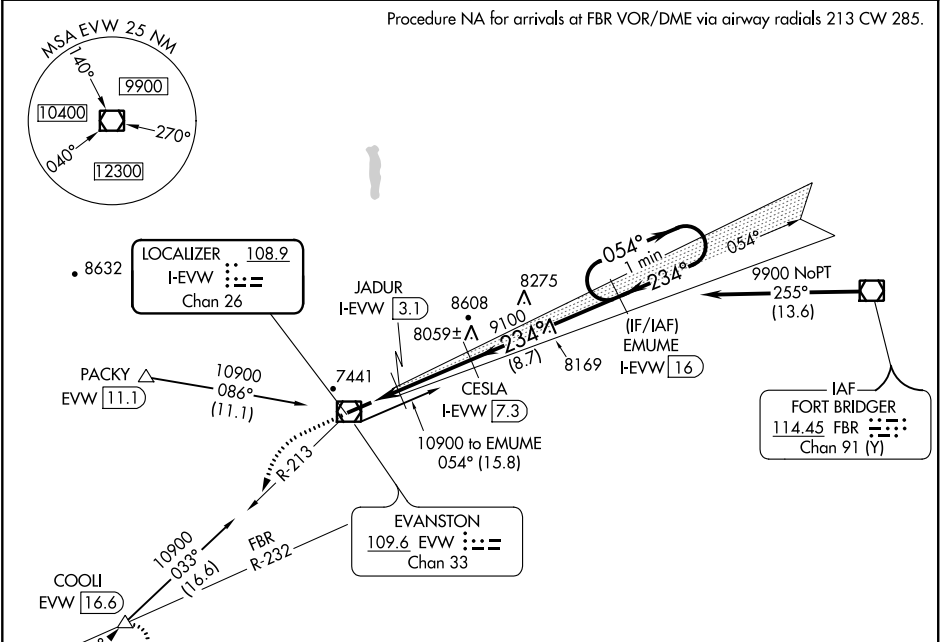




Diagram illustrating the approach path with distances: 0.8, 0.9 NM, 4.2 NM, 8.7 NM.




Diagram illustrating the missed approach climb-in-hold pattern at 234° from the FAF.

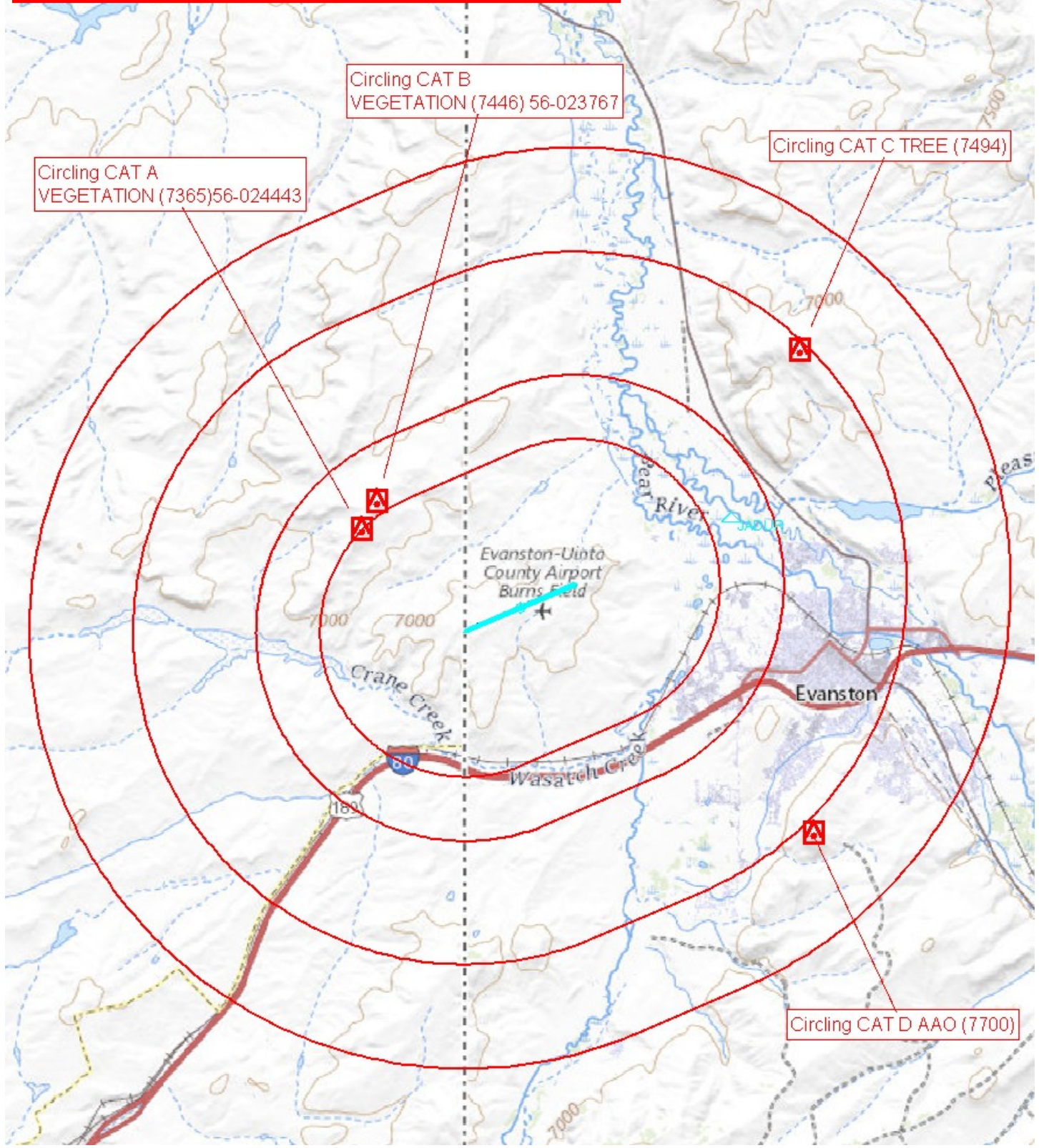
