Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

**RWY 2:** 400-2 3/4 OR STANDARD WITH MINIMUM CLIMB OF 400 FEET PER NM TO 1200 OR 1800-3 FOR VCOA.

**RWY 20:** 300-1 1/2 OR STANDARD WITH MINIMUM CLIMB OF 285 FEET PER NM TO 3900 OR 1800-3 FOR VCOA.

**TEXTUAL DEPARTURE PROCEDURES:**

**RWY 2:** CLIMB ON HEADING 021.71 TO 2200 BEFORE TURNING RIGHT.

**RWY 20:** CLIMB ON HEADING 201.71 TO 1900 BEFORE TURNING LEFT.

**VISUAL CLIMB OVER AIRPORT:**

**ALL RUNWAYS:** OBTAIN ATC APPROVAL FOR VCOA WHEN REQUESTING IFR CLEARANCE. CLIMB IN VISUAL CONDITIONS TO CROSS MCMINN COUNTY AIRPORT AT OR ABOVE 2500 BEFORE PROCEEDING ON COURSE.
