Bearings, headings, courses, tracks and radials are magnetic. Elevation and altitudes are in feet MSL. Altitudes are minimum altitudes unless otherwise indicated.
Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

TAKEOFF MINIMUMS:

RWY 16, 34, NA AT NIGHT – UNLIT OBSTACLES

RWY 16, 800-2 WITH MINIMUM CLIMB OF 500 FEET PER NM TO 4500, OR 2700-3 FOR CLIMB IN VISUAL CONDITIONS.

RWY 34, 900-2 ½ WITH MINIMUM CLIMB OF 500 FEET PER NM TO 4500, OR 2700-3 FOR CLIMB IN VISUAL CONDITIONS.

TEXTUAL DEPARTURE PROCEDURES:

RWY 16, CLIMB DIRECT RBG VOR/DME, CONTINUE CLIMB IN RBG VOR/DME HOLDING PATTERN (HOLD N, RT, 163.00 INBOUND) TO CROSS RBG VOR/DME AT OR ABOVE MEA/MCA FOR ROUTE OF FLIGHT, THENCE...

RWY 34, CLIMB HEADING 341.94 TO 2900 BEFORE PROCEEDING ON COURSE, THENCE...

...OR FOR CLIMB IN VISUAL CONDITIONS, CROSS ROSEBURG RGNL AIRPORT SOUTHBOUND AT OR ABOVE 3100 THEN DIRECT RBG VOR/DME, CONTINUE CLIMB IN RBG VOR/DME HOLDING PATTERN (HOLD N, RT, 163.00 INBOUND) TO CROSS RBG VOR/DME AT OR ABOVE MEA/MCA FOR ROUTE OF FLIGHT. WHEN EXECUTING VCOA, NOTIFY ATC PRIOR TO DEPARTURE.

NOTE: RWY 16, POLE, 54 FEET FROM DER, 290 FEET LEFT OF CENTERLINE, 13 FEET AGL/525 FEET MSL. VEHICLE ON ROAD, 269 FEET FROM DER, 259 FEET RIGHT OF CENTERLINE, 15 FEET AGL/528 FEET MSL. TREES, BEGINNING 296 FEET FROM DER, 437 FEET LEFT OF CENTERLINE, UP TO 100 FEET AGL/611 FEET MSL. AREA OF TREES AND TOWERS, 1.27 NM FROM DER BEGINNING 466 FEET RIGHT OF CENTERLINE, UP TO 123 FEET AGL/1268 FEET MSL.

NOTE: RWY 34, POLE, 238 FEET FROM DER, 361 FEET LEFT OF CENTERLINE, 28 FEET AGL/557 FEET MSL. TREES, BEGINNING 245 FEET FROM DER, LEFT AND RIGHT OF CENTERLINE, UP TO 100 FEET AGL/1339 FEET MSL. SIGN, 390 FEET FROM DER, 557 FEET LEFT OF CENTERLINE, 60 FEET AGL/565 FEET MSL. SIGN, 620 FEET FROM DER, 557 FEET LEFT OF CENTERLINE, 60 FEET AGL/565 FEET MSL.
