TREES BEGINNING 622 FT FROM DER, LEFT AND RIGHT OF CENTERLINE, UP TO 24 FT AGL/480 FT MSL. POLE 1002 FT FROM DER, 548 FT LEFT OF CENTERLINE, 33 FT AGL/488 FT MSL.
