RWY 3: STANDARD WITH A MINIMUM CLIMB OF 350 FT PER NM TO 4800 OR 3500 - 3 FOR VCOA.  
RWY 21: STANDARD.

**TEXTUAL DEPARTURE PROCEDURES:**

RWY 3: CLIMB ON HEADING 033.26 TO 3300 BEFORE PROCEEDING ON COURSE.  
RWY 21: CLIMB ON HEADING 213.26 TO 2500 BEFORE TURNING LEFT.

**VISUAL CLIMB OVER AIRPORT:**

RWY 3: OBTAIN ATC APPROVAL FOR VCOA WHEN REQUESTING IFR CLEARANCE. CLIMB IN VISUAL CONDITIONS TO CROSS GILMER COUNTY AIRPORT AT OR ABOVE 3500 BEFORE PROCEEDING ON COURSE.
