RWY 28: 300-2 1/4 OR STANDARD WITH MINIMUM CLIMB OF 260 FEET PER NM TO 1200 OR ALTERNATIVELY, WITH STANDARD TAKEOFF MINIMUMS AND A NORMAL 200 FT PER NM CLIMB GRADIENT, TAKEOFF MUST OCCUR NO LATER THAN 1500 FT PRIOR TO DER.
