VISUAL CLIMB OVER AIRPORT:

RWY 21: OBTAIN ATC APPROVAL FOR VCOA WHEN REQUESTING IFR CLEARANCE. CLIMB IN VISUAL CONDITIONS TO CROSS FORT STOCKTON-PECOS COUNTY AIRPORT AT OR ABOVE 3700 BEFORE PROCEEDING ON COURSE.
