TAKEOFF RUNWAY 6: CLIMB ON HEADING 058.10 OR AS ASSIGNED FOR VECTORS TO ASSIGNED ROUTE.

TAKEOFF RUNWAY 24: CLIMB ON HEADING 238.12 OR AS ASSIGNED UNTIL RSW 2.3 DME, THEN TURN RIGHT TO HEADING 270. LEAVING 3000, TURN RIGHT HEADING 310. EXPECT RADAR VECTORS TO ASSIGNED ROUTE.

ALL AIRCRAFT MAINTAIN 4000 OR ASSIGNED LOWER ALTITUDE. EXPECT FURTHER CLEARANCE TO FILED ALTITUDE WITHIN 10 MINUTES AFTER DEPARTURE.
