Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

TAKEOFF MINIMUMS:

RWY 5: 300 - 2 WITH MINIMUM CLIMB OF 250 FT PER NM TO 4000, OR 2700-3 FOR CLIMB IN VISUAL CONDITIONS.

RWY 23: 300 - 1 WITH MINIMUM CLIMB OF 285 FT PER NM TO 4400, OR STANDARD WITH MINIMUM CLIMB OF 340 FT PER NM TO 4400, OR 2700-3 FOR CLIMB IN VISUAL CONDITIONS.

TEXTUAL DEPARTURE PROCEDURES:

RWY 5: CLIMB ON HEADING 054.36 TO 4000 BEFORE TURNING RIGHT.

RWY 23: CLIMB ON HEADING 234.37 TO 4400 BEFORE TURNING LEFT.

VISUAL CLIMB OVER AIRPORT:

ALL RUNWAYS: OBTAIN ATC APPROVAL FOR VCOA WHEN REQUESTING IFR CLEARANCE. CLIMB IN VISUAL CONDITIONS, TO CROSS GREENEVILLE MUNI AIRPORT AT OR ABOVE 4200 BEFORE PROCEEDING ON COURSE.
